She took him to the pilots lounge of her airline, and told all in that place that this young Marine was her guest, and that he would be spending the night in the lounge until it was time for him to check onto his flight with the other airline.

In Matthew 25:35, Jesus said this, "For I was hungry and you gave me food, I was thirsty and you gave me drink, I was a stranger and you welcomed me." In Hebrews 13:2 The Bible states "Do not neglect to show hospitality to strangers, for thereby some have entertained angels."

I know the Marine is mortal, but maybe, just maybe, the attendant was an angel. We will never know, but I know kindness when I see it, and this was an act of kindness to our brother. Semper Fi Marine!
