SCHOLARSHIP COMMITTEE PROPOSAL

Members,

At the April Meeting we will be discussing and hopefully voting on the following proposal that has been talked about for some time now. We, the Detachment Scholarship Committee hope you can support this endeavor.

The Scholarship Committee:

Jim Powell Sam DiValentino Bill McBride Joe Kier

SCHOLARSHIP PROPOSAL

To start, we would like to fund two \$500.00 scholarships per year and build a scholarship endowment of at least \$20,000.00 to fund these two (2) \$500.00 scholarships in perpetuity. One scholarship shall be named the Don H. Gee Memorial Scholarship and the second shall be named the Ellis "Budd" Pearce III Memorial Scholarship.

Funding:

To fund these Scholarships, it is proposed that the Central Bucks Detachment donate a minimum of \$1000.00 each year to the Marine Corps League of Pennsylvania Scholarship Program until they become self-sustaining in perpetuity. The money will be deposited with the Scholarship Administrator designated by the Department of Pennsylvania.

Our endowment fund can be built to a level that makes it self-sustaining which is believed to be the amount noted above. The endowment could be built via the following:

- a) Fundraising of the Detachment (i.e. Rose Program, Memorial Day)
- b) Solicitation from MCL Detachment 636 membership
- c) Solicitations from local businesses (i.e. Doctors, Car Dealers, etc.)
- d) Solicitations from general public.

Proposed Scholarship Rules:

These Memorial Scholarships will be administered with the following rules applied in the listed order.

Eligible Applicants:

(1) Central Bucks Detachment Member sponsored applications. The sponsor member must be in good standing. Eligible applicants are the member, their spouses, children and grand-children. If there are none then;

- (2) Applications sponsored by Members of any MCL Detachment in Bucks County Pennsylvania. The sponsor member must be in good standing. Eligible applicants in this category are the member, their spouses, children and grandchildren. If there are none then;
- (3) Applications sponsored by Members of any Detachment in the Department of Pennsylva-nia. The sponsor member must be in good standing. Eligible applicants in this category are the member, their spouses, children and grandchildren.

Determination of Scholarships:

The Don H. Gee Memorial Scholarship will be awarded first and the Ellis "Budd" Pearce III Memorial Scholarship will be awarded next.

- (1) If there are more than two (2) Central Bucks Detachment Member Sponsored applications then:
 - (a) A family* shall only be eligible for one of these scholarships. If a family has two (2) or more Member Sponsored applications the person who is entering the higher year of ed-ucation shall be the person eligible to receive the scholarship. An example is if a mem-ber has a spouse going into their 3rd year of school and a child going into their 2nd year of school, the spouse is the eligible person.
 - (b) If after resolution of 4(a) above there are still more than two (2) Central Bucks Detach-ment Sponsored applications the following order of priority is to be followed:
 - (i) Member Sponsor is a Detachment Elected Officer (note1)
 - (ii) Member Sponsor is a Detachment Appointed Officer (note 1)
 - (iii) Member Sponsor is a Detachment Member (note 1)
- (2) If there are one (1) or two (2) Central Bucks Detachment Member Sponsored applications they shall be awarded without any additional criteria.
- (3) If there is one (1) Central Bucks Detachment Member Sponsored application it shall be award without any additional criteria.
- (4) If there are still Memorial Scholarships available then:
 - (a) **Eligibility Section (2)** will be followed first and if there are still no eligible Sponsored applications then **Eligibility Section (3)** will be followed.
 - (b) If there are more Eligible Applicants than there are available Scholarships then the fol-lowing order of priority is to be followed:
 - (i) Department Elected Officer Sponsor (note 1)
 - (ii) Department Appointed Officer Sponsor (note 1)
 - (iii)Department Member Sponsor (note 1)

SCHOLARSHIP COMMITTEE PROPOSAL

(CONTINUED)

Administration:

We are proposing that this program will be administered by Department of Pennsylvania. Scholarship Committee using the rules set forth above.

Also, we are proposing that an endowment fund be built and that it be managed by the Program Administrator as determined by the Department of Pennsylvania in conjunction with their Investment Management Company (Morgan Stanley as of this time).

It is also proposed that the monies be invested and/or managed as per the official investment policy of the Department of Pennsylvania and the Program Administrator.

* a family is considered to be a member in good standing and anyone they are sponsoring.

(note 1): if 2 or more, Member Sponsors with most years of Marine Corps League membership is used to determine order. If after determining most years of membership there are still 2 or more eligible applicants then they are to be awarded at the discretion of the Scholarship Committee.


