DETACHMENTS MARKS 236th MARINE CORPS BIRTHDAY

More than 62 members and guests attended the Detachment's 236th Marine Corps Birthday at the Waterwheel Inn in Doylestown on Nov. 12.

The traditional cake-cutting and presentation of the first pieces of Birthday Cake to the youngest and oldest Marines present by Commandant Pearce was the culmination of the annual celebration. As Pearce explained the significance of the cake ceremony the oldest Marine present, **Bill Mickelson** (85), passed the first piece of cake to the youngest Marine present, **PFC Steven A. Gentile** (22).

Following dinner, Commandant Pearce presented awards to deserving Detachment members.

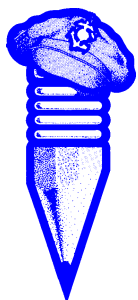

There were 17 members present including all officers except the Chaplain. Distinguished members in attendance included **Past Commandants Don Gee and Bob Sundling; Department of Pennsylvania Junior Vice Commandant/Junior Past Commandant Jim Powell; Marine of the Year Jack Gentile; and Past Department of New Jersey Commandant/Past National Northeast Division Vice Commandant Ed Hoth.**

Sick Call: Past Commandant Bill Miller is recuperating from double knee replacement surgery and expects to attend the Birthday Ball.

* **Marine Wil Haas** has undergone numerous medical procedures for the last six months and is progressing well.

The **Minutes** of the October Meeting as published in *Listen Up!* were unanimously approved.

The **Paymaster's Report** was presented and unanimously accepted.

OFFICER REPORTS

Commandant Budd Pearce, PC, reported he and **Sergeant-at-Arms Bob Sundling, PC**, will be providing the Color Guard on Veterans Day at Log College School on Veterans Day.

* He also reported Plumstead Christian School will be holding its annual Veterans Day ceremony on Saturday and recommended members attend this event.

* He will also attend the rededication of the WW I Memorial in New Britain on Nov. 12.

* He reported about preventive maintenance performed on the Detachment's Parade Float.

There being no further business, the meeting was adjourned until 7:30 p.m. on Wednesday, Dec. 14, 2011.

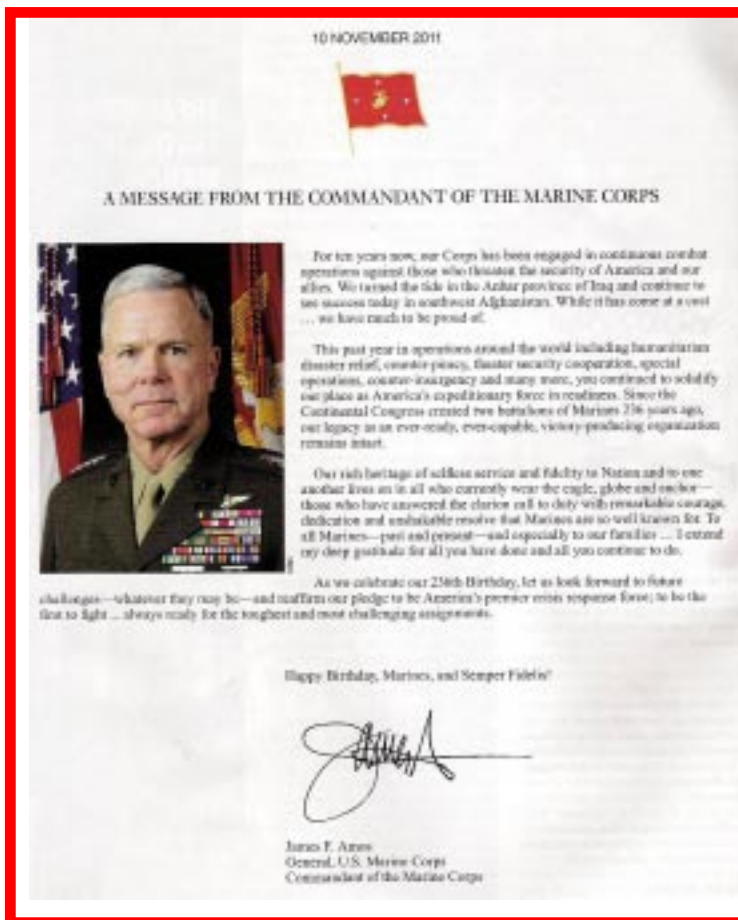

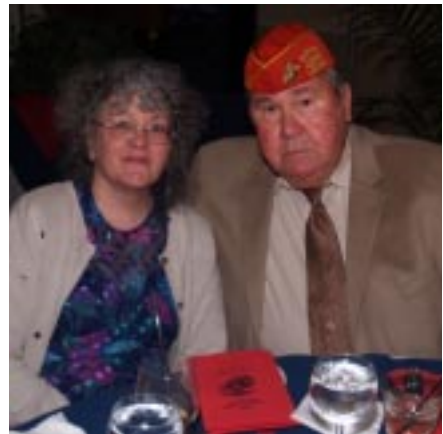

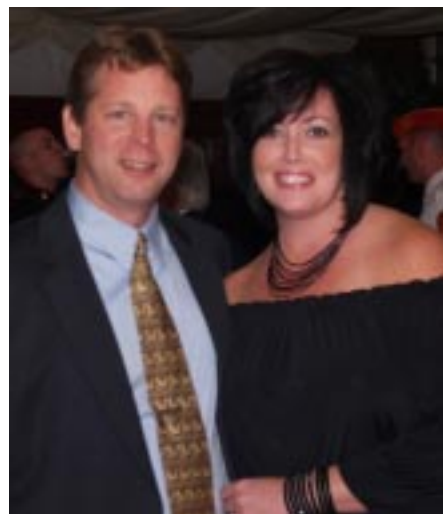
