



Marine Corps History

Last September I visited my ailing cousin in Alabama for an afternoon of reminiscing and hearing stories about his time in the Marine Corps. Bobby Nail served on the maiden voyage of the USS Kitty Hawk and recalls the ship's role in the Cuban Missile Crisis. In October of 1962, the USA and the Soviet Union had a tense 13 day standoff due to the Americans discovering a Soviet ballistic missile deployment in Cuba.



Most people with first-hand knowledge of this event

consider it the closest the two countries came to turning the cold war into a full-scale nuclear war. The USS Kitty Hawk was stationed in the sea of Japan during the crisis and conducted some exercises to exhibit our strength to the watching Soviets. Even now, Bobby is reluctant to share some of the secrets of that mission.

Bobby is proud of his service during that tense time, and also proud to have remained on the Kitty Hawk long enough to be a part of the Marine detail that was charged with guarding President John F Kennedy on June 6, 1963 when he visited the ship to acknowledge the crew and the ship's role during those difficult days. It only took a quick google search to find the picture above, where Bobby and his fellow Marines stood alongside the podium as President Kennedy gave a speech on the deck. The President boarded the Kitty Hawk after reviewing the Pacific Fleet off the coast of San Diego, California, then gathered the ship's crew, several visiting dignitaries and the press corps for this speech.

Bobby was honored to be the lead Marine in the detail and is the one standing closest to the podium. As he described the day, he mentioned that they had required him to wear a pink epaulette, which would serve to designate his seniority as compared to the other Marines in the detail. He had not seen this specific uniform addition before or since and remains curious about it's history.

I have searched the internet and have not been able to find any information about this epaulette. The picture above, along with Bobby's stories, are the only evidence I can uncover to prove it ever existed. If there are any Marines out there that know anything about the pink epaulette, Cousin Bobby and I would both be very grateful for some help solving this mystery.


