Court Says Promise to Vets Not Valid

FORT WALTON BEACH, FL--True to his word, **Col. George "Bud" Day**, attorney, Medal of Honor recipient and former POW, officially filed a petition with the U. S. Supreme Court on Jan. 24 seeking justice for hundreds of thousands of live WWII/ Korea era military retirees.

The U.S. Court of Appeals for the Federal Circuit, Washington, D.C. ruled last November that Military Retirees have no legal standing and the U.S. government was authorized to break the offer of lifetime, free medical care to those servicemen and women who served their country honorably for 20+ years.

Col. Day expects a hearing before the Supreme Court and reversal of the November 2002 Federal Circuit order.

"This battle is not over. We were all aware that whichever way the Court of Appeals ruled, that the case would be appealed to the U.S. Supreme Court. Much to my surprise, it is 'G.I. Joe' that is appealing" says Day, the attorney representing some 23,000 clients. "We will employ every offensive weapon we have at our disposal for presentation of this case to the U.S. Supreme Court".

"Rest will come when every possible argument is exhausted. Our fight is geared to convince the U. S. Supreme Court that military retirees are legally guaranteed to receive the benefits they were promised by the government when they signed up to devote their lives to the service of their country. We should never have been forced to wage this fight, but we are in it and four Federal Appeals Court Judges in their support of our cause gives strong hope."

Col. Day believes his arguments are strong and our government cannot be allowed to trample her warriors in favor of budgetary waste and continued political pork abuse.

One of the most highly decorated military officers since Gen. Douglas MacArthur, Col. Day took on this case more than six years ago.

"This has been the crusade of my life and I won't rest until the last round is fired.

"I hope every military retiree and veteran takes the Appeals Court set-back personally and demand your Congressional Representative and Senators take legislative action in conjunction with our legal fight to right this wrong," Day states.

Officials at the Department of Defense breached their contract with military retirees over the age of 65 - mostly World War II and Korea War career veterans - to receive medical care in military hospitals.

DoD NEWS BRIEFS

STATESIDE SPACE-A COMING FOR FAMILIES

Defense transportation officials have announced a one-year test to offer spaceavailable travel privileges within the continental United States to family members accompanied by their sponsors. The test begins April 1, 2003, and will continue through March 31, 2004. Space-A flights will be available to dependents of both active-duty members and military retirees. Participants will have the same eligibility category as their sponsors. To register for Space-A travel, active-duty sponsors must be on leave or a pass and remain in that status while awaiting travel and through the entire travel period. Retirees may sign up 60 days in advance but not before the test begins April 1. Additional information is available at http:/ /public.scott.af.mil/index.html.

CLASS-ACTION LAWSUIT FILED AGAINST TRIWEST

Tucson attorneys have filed a classaction lawsuit in the U.S. District Court for Arizona on behalf of some 562,000 service members whose personal information was stolen during a burglary at the Phoenix office of TriWest Healthcare Alliance. The suit alleges that TriWest was negligent by failing to protect sensitive personal information it collected from plaintiffs Lt. Col. Michael Stollenwerk and his wife Andrea De Gatica. The lawsuit also asserts the company should have provided a written warning before collecting individual Social Security numbers. TriWest maintains records for Tricare beneficiaries from Arizona, Colorado, Idaho, Iowa, Kansas, Minnesota, Missouri, Montana, Nebraska, Nevada, New Mexico, North Dakota, South Dakota, Utah, Wyoming and extreme Western Texas.

SHADES OF GREEN RE-OPENS IN FLORIDA

Reservation lines are now open for the new, improved Armed Forces Recreation Center, Shades of Green hotel, on Walt Disney World Resort in Orlando, FL. Shades of Green had been closed since early 2002 for expansion and complete renovation.

Meanwhile, guests eligible to stay there have been booked into Disney's Contemporary Resort at Shades of Green's daily rates. The rates are based on rank from a low of \$66 for E-1s through E-5s to \$99 for senior officers. The range starting Dec. 15 will be \$70 to \$116. All rooms will have ironing boards and televisions. Also available will be refrigerators, wireless TV keyboards and 12 hours of Internet access. DOD EXPANDS ABILITY TO PROVIDE BLOOD

The Department of Defense has announced a "safety net" for obtaining blood and blood products if military collection centers cannot meet the needs of the Armed Forces. Currently, the military centers have provided a sufficient supply of blood products to meet overall needs, including all of the more than 17,000 units shipped in support of Operation Enduring Freedom. **Dr. William Winkenwerder**. Assistant Secre-

tary of Defense for Health Affairs, noted, "The need for blood products increases significantly as new operations begin or the current operations tempo increases. In such situations, the Armed Services Blood Program Office historically has contracted to purchase blood from civilian agencies." In Operation Desert Storm, civilian agencies provided about 20 percent of the blood that was shipped. On Jan. 27, the ASBPO contracted with America's Blood Centers for DoD to purchase blood products from ABC if needed.

SOCIAL SECURITY AGE ELIGIBILITY RISES

Effective January of this year, individuals born in 1938 will have to wait until two months after age 65 before becoming eligible for full Social Security retirement. In 2004, those born in 1939 will be not be eligible until four months after reaching age 65. Those born on January 1 will fall under the regulations of the previous year.

The full retirement age will continue to rise annually until it reaches age 67 for those born in 1960 or later. Individuals can still retire as early as age 62, but they will receive reduced payments. The new Social Security age requirements do not effect the Medicare entitlement age, which remains at 65.

Thousands Mourn WWII Ace Joe Foss

Nearly 2,000 people came together in early January at Scottsdale (AZ) Bible Church for a farewell befitting **Joe Foss**, a flying ace who dedicated his life to public service, his church and family, reported *The Arizona Republic*.

Actor Charlton Heston, another member of Foss' generation, gave a brief but powerful tribute to his friend despite limitations caused by symptoms of Alzheimer's disease.


Foss was also a mentor to NBC news anchorman **Tom Brokaw**, who said in videotaped remarks that Foss had the "aura of a hero but the openness of the guy next door."

Former First Lady **Barbara Bush** sent her family's regards in a letter saying, "The whole Bush family thought the world of you."

The memorial service was full of military pomp and circumstance, including a flyover by F-16s in a missing-man formation, *The Republic* said.

Foss was also a former governor of South Dakota, first commissioner of the American Football League and a past president of the National Rifle Assn., which Heston leads.

Foss died Jan. 1 at 87 in Scottsdale after suffering an aneurysm in Michigan in October.

This forced the retired members to buy Medicare B and other supplemental insurance costing thousands of dollars per year, to have the coverage which the U.S. previously provided for decades. The payment of several hundred dollars per month is cost prohibitive for many elderly G.I.s and particularly widows.

"After 20 years of care in military hospitals, my wife and I were kicked out and forced to rely on Medicare," says Robert "Bob" Reinlie, one of the plaintiff's. "This is not what I was promised when I pledged to serve my country for 20 years. I'm astonished that at the age of 82 years I must now fight for the medical care I earned."
