They took turns talking to him and finally he agreed to turn over his weapons and ammo to the Marine Officer. He handed over three pistols and a lot of ammo.

God in His kindness allowed this man and his wife to pass away not too long after this incident occurred. We averted what may have been a tragic end of life, and allowed God to work out the lives of this couple according to His plan.

Our Supreme Commandant has a plan for all of us. We need to let Him work in our lives so that we can follow what He wants us to do. Trust your hard times to Him, and thank Him for your good times. He has a plan for you, let Him work His plan in your life.
