National Commandant, William Galvin was elected to lead the Marine Corps League in the coming year. All other Officers also remain in their same Billets for 1987-1988. The only change is the election of Lamar Golden to the office of National Northeast Assistant Division Vice Commandant for a period of one year.

Paymaster Robert Schatz has purchased a Computer for the Department of Pennsylvania, Bob will be reporting on this new addition to the Marine Corps League family at the First Quarter Staff Meeting on 19 September 1987.

My congratulations to Bob Schatz on being elected as Vice President of the Southeast Veterans Center Advisory Board.

The 64th National Convention of the Marine Corps League was held in Phoenix, Arizona, from 10 to 14 August 1987. This report covers the hilights of the convention.

- 1. <u>Delegates</u>. The Department of Pennsylvania registered 20 delegates giving the Department 933 votes for the largest strength on board. I certainty appreciated the members who came west and represented their Detachment and the Department of PA. It felt good, to look around and see Pennsylvania in force. My thanks to everyone who attended and got involved.
- .2. <u>Committee Reports</u>. The first two days of business were devoted to reports by the various Chairmen, listed below are only excerpts. Any member desiring a full report on a committee, please contact me.

a. 1988 Budget

The 1988 projected income for National Marine Corps League is \$410,920.

b. National Comptroller

The Comptroller reported that for the first time in 15 years, all bills have been paid that were due and on time, also that the MCL is a fraternal organization of veterans and comes under the IRS code as a 501-C4.

c. Insurance

A certificate of insurance was issued to the Department showing comprehensive general liability, aggregate, 500,000, each occurrence 500,000, excess liability \$2000 each occurrance, aggregate \$2000. The rifle match will come under this coverage.

d. VAVS

There were 48 joint reviews this year and 23,945 volunteer hours from 30 September 1986 to 31 March 1987 with the goal in the coming months to get over 50,000 hours.

e. Uniform

Members can obtain a men's or women white short sleeve shirt through Van Husen at \$10.50 by calling 1-800-528-6050, ext 138, credit cards accepted. There will be a new updated MCL uniform code booklet published.

f. Youth Physical Fitness

The Chairman reviewed the 1987 program and its objectives, copies will be available at the Department's 1st quarter staff meeting.

g. Resolutions

The Department of N.J. submitted a resolution to revise the system of collecting dues, this was referred to the By-Laws committee. The National Chaplain submitted a resolution to wear a religious symbol on covers worn by Chaplains, this was referred to the Uniform committee. A resolution was passed to commend LtCol Oliver North on his resolute manner and conduct in the recent congression hearings.

* Comptroller turned allowance back to National Headquarters for the purchase of a computer.

h. Christmas Card

This committee lost a member and a friend this past year, but it continues to march and make bucks for the Marine Corps League, earned income to date is \$8818.38. Joe Wilson will long be remembered.

i. Vietnam Veterans Affairs Committee

This report covers Agent Orange, POW/NIA, Post Traumatic Stress, and VA Travel Pay. This report is in depth and was prepared by Paul Sutton and was delivered by George Stack, Chief of Staff, MCL.

j. MCL Exhibit

This year's exhibit was being held at the Washington Sheraton, 25-27 August 1987. Last year no monies were made to share with the MCL on the exhibit, this year, it is anticipated the League will derive \$10,000 from the event.

k. Young Marines

The report was given by the National Director of Young Marines and was directed on most part to the 7th National Encampment in Michigan, from verbal and written reports, it appears it was an over-reaction by the press for some cheap publicity to sell newspapers. The Young Marines are financialy sound, but will be assesed \$1.00 per member for insurance in the coming year.

- n. Military Order of the Iron Nike Award was awarded to James Webb, Secretary of the Navy, the Dickey Chapelle Award was awarded to Grace N. Hopper, Naval Officer.
- 3. National Commandant. Reported that as a result of a Team Effort, membership was on the up swing in the MCL. (1986 23908, 1987 24241) The MCL magazine has become a first class product. The League's Service Officer is doing an outstanding job in representing veterans. He also reported that Executive Director Robert Forsyth is managing the office at National Headquarters and his Staff in a well run business manner.
- 4. National Executive Director. Bob Forsyth gave his report covering many items, from print-Outs, dual membership, merchandise, and the life memberships in which he stated that all Life Memberships are put into the Life Membership Fund, as a result the League is not aquiring the \$10.00 renewal or the \$13.00 new membership fee, with the large influx of Life Members this past year, its been putting a drain on the General Fund to supply the money to bring about membership ie., regular cards, metal plates, engraving time spent putting information into the computer, envelopes and postage. He has suggested, that we need some kind of charge to Life Members such as an initiation fee to cover costs. He would like Leaguers to discuss this matter and determine how we should approach the situation.
- 5. National Senior Vice Commandant. The Sr. Vice convened a Commandant's Council on Thursday at 0700 and the below listed subjects were discussed.
- a. Commandant's Council Meetings will be held on Tuesday of the National Convention at 1830. (approved)
- b. This was more of a reminder, that under the new By-Laws Detachments must hold elections, between 1 October and 15 May each year and installations must be conducted within 30 days with installation reports submitted within 15 days of the installation. A list was given to me, from National on Detachments, that need submissiom, and they are; All Divisions Lancaster County Elk Horn

- c. There has been problems on the transfer of members from one Detachment to another, a transfer form will be produced and utilized. (approved)
- d. All membership transmittals, coming off the computer at National Headquarters will be sent to the Department Adjutant/Paymaster or to the one handling the accounting of membership. (approved)
- e. Marine Corps League Publication, need input, plus short items and black & white photos.
- f. Master Card/Visa in the works.
- g. Detachments with 15 or more members will be eligble for a 100% certificate. (approved
- h. Recruiter of the Year Award, It was recommended that the medal be up-graded from silver to gold to the recipient. (disapproved)
- i. Life members must be transmitted each year to receive card.
- j. The motion to insert a ritual book and by-laws to each starter kit was amended and to continue to only issue them, when a new charter is approved.

- 6. National Jr. Vice Commandant. The Jr. Vice awarded Convention Streamers to all Detachments that had their Colors on the Convention floor.

 The Recruiter of the year received a silver medal & Citation for signing up 145 members, this was Charles Laberge from the Captiol Marines out of Washington D.C..

 The second place award went to Gil Gray PNC, who recruited 95 new members.

 Pennsylvania received two Citations, one going to John Wilson (5 members) and one to Paul Seton (8 members)
- 7. National Judge Advocate. Many additions, changes and spelling were made to the National By-Laws. The Executive Director has indicated that the new revised copies will be out in 60 days. I have forwarded a copy of these changes to our Department Judge Advocate, Dan Bullook.
- 8. National Chaplain. The Chaplain conducted a very solemn and beautiful service for our deceased members in the convention room on Thursday evening. The 1988 service will be held in a church in Cincinatti.
- 9. Northeast National Division Vice Commandant. In conjunction with the 3 Departments that include, New York, New Jersey, and Pennsylvania, Division Vice Commandant, Edwin Gallagher presented a MIA/POW flag to the National Marine Corps League for display at meetings.

Vice Commandant Gallagher has sent monies in the amount of \$3, 900 to the Secretary of the Navy for a stained window to be installed in the Chapel at Parris Island in the memory of deceased Marines from the States of New York, New Jersey, and Pennsylvania. Each Department contributed \$1300. A dedication ceremony will take place at Parris Island when completed.

10. Other Business. The motion to let Corpsmen become regular members was defeated. There was controversy over the Awards Committee in selecting the Marine of the Year for 1987. The Convention body elected to ensure by vote that it will go back to the Marine of the Year Society, but an amendment with guide lines will have to be drawn up and presented to the By-Laws committee.

Much discussion was held on the present lease of National Headquarters, which expires in September of 1989. Having our own building in the D.C. area was talked about, no action taken at this time.

Life Membership certificates will be available in the near future, Life Members can purchase them for a nominal fee.

The Devil Dogs, Marine Corps League Auxiliary, and Fleas have been assessed .25 per member to cover the increased cost of insurance.

Distinguished Service Awards were presented by the National Commandant to; Patrick Cody, VAVS-Russel Gross, Christmas Card Committee-Andrew Lewandowski, POW/MIA Committee-Frank English, Christmas Card Committee/Assistant N.E. Division Vice Commandant.

Charters were presented by the National Commandant, to the Department of PA for the Tyrone Area Detachment and the Hidden Bell Detachment of Quakertown.

The 1987/1988 National elected officers are; Commandant, William Galvin, Sr Vice, Linward Liner, Jr Vice, Raymond Berling, Judge Advocate, Edward Hoffman and for the first time a new elected Assistant N.E. Division Vice Commandant. Lamar Golden.

Clem Russel a Leaguer for 50 years was made an Honorary National Commandant.

The National Mid-Winter meetings will be held in Arlington, VA in February.

Tentative bids were received from Mobile, Alabana and Florida for 1989. Conventions

The 64th National Convention at Phoenix was dedicated to the memory of Joseph Wilson.
